## **Officer and Board of Trustees Nomination Form**

### **Qualifications for Nomination**

Trustees are required to be the age of majority in the state of Indiana, residents of the United States, and a majority of the Trustees must reside in the United States.

### **Term of Office**

Term length: With exceptions granted by 75% of the SILA Foundation Board of Trustees, all Officers shall serve a two year term. With the exception of the President and the Vice President of SILA Relations, all other Officers will have staggered terms. The Treasurer and the Vice President of Compliance are elected in even years and the Secretary and the Vice President of Services & Scholarship elected in odd years or until their successors are elected. Their term of office will follow the Corporation's fiscal year, January 1st to December 31st of a given year and acceptance of the office.

Term limits: All Officers except the Vice President of SILA Relations may serve for a maximum of two (2) consecutive terms in the same officer position. Trustees will be elected for a term of two (2) consecutive years or until their successors are elected. Except for the Vice President of SILA Relations, Officers and/or Trustees may serve up to two (2) consecutive terms on the Board and must sit out at least one year before holding an elected position as Officer or Trustee. Trustees shall hold no more than one elected office on the SILA Foundation Board at a time.
